

## FD/MAS GLOBAL AWARENESS ART CONTEST ARTWORK RELEASE FORM

This Artwork Release Form (“Agreement”) is entered into by the undersigned (“Artist”) and the FD/MAS Alliance, host of the FD/MAS Global Awareness Art Contest (“Contest”). If the Artist is under 18 years of age when signing this form, a parent or guardian (“Guardian”) must also sign the Agreement.

By submitting an entry (“Artwork”) to the Contest, the Artist, being the legal owner of, or having the legal right to the Artwork, grants FD/MAS Alliance the non-exclusive, perpetual, worldwide right to reproduce, promote, publish, and otherwise use the Artwork in any way, in any media, and for any purpose as FD/MAS Alliance sees fit, without having to seek permission or review from, and without consideration or notification to the Artist or any third party.

Copyright ownership of the Artwork remains with the Artist and, at all relevant times, will be attributed to the Artist. Should the Artist sell the original artwork after submitting to the competition, it is the Artist’s responsibility to disclose to the buyer that FD/MAS Alliance has been granted permission to use my art on the FD/MAS Alliance website, in print materials, and in web communications.

The Artist further grants FD/MAS Alliance the non-exclusive right to create derivative products based on the Artwork, including but not limited to reproduced prints, digital downloads, video compilations, social media posts, and all other related purposes, including the right to assign, sub-license, transfer, and grant the same rights to others.

Artwork displayed, reproduced, or otherwise shared by FD/MAS Alliance may include a combination any of the following: FD/MAS Alliance's logo; Organizational sponsor(s) logo; and/or the Artist’s name, age, and disease affiliation(s) as defined on page 2 of the Agreement.

The Artist consents to and authorizes FD/MAS Alliance to use the Artwork in the above manners even if the Artwork contains or consists of any medical records or medical information, personal or otherwise.

The Artist releases, waives, forever discharges, and holds harmless all liabilities or claims against FD/MAS Alliance and its affiliated partners and sponsors, including in each case, without limitation, their directors, officers, employees, volunteers, and agents (“Release Parties”), for any blurring, distortions, quotations from or alterations made to the Artwork for subsequent reproduction, transformation, processing, or publication, whether intentional or otherwise.

This Agreement shall be governed by and construed in accordance with Maryland state law. By executing this Agreement, the Artist consents to the exercise of personal jurisdiction over it by the courts of the state of Maryland. Any legal action in connection with this Agreement shall be brought to or maintained only in the courts of the state of Maryland.
